Today i.e 13/9/2021 at 10:20 PM received an information that on the same day at around 10:00 PM one empty truck B/Regn. No. AS18C-0818 driven by one Shahjahan Ali (38) s/o Abdul Kasheem of Tiapara, PO, Tiapara Balijana, Goalpara, Assam,783129 proceeding towards Dimapur along with one handyman in the truck were stopped at Lamkhai Keithelmanbi Militay Colony along NH-2 by one unknown armed miscreant for extorting money from them. The armed miscreant threatened the driver by shooting 2/3 live rounds at the front tyres of the empty truck and forcibly took a sum of Rs. 4000/-(four thousand) only from the driver. However, no physical injury/casuality was done to them.
