



Subject:- First Information report.

Sir,

I am to inform you that on 30/01/2024 at about 10:00 am myself along with 2(two) other labourers namely Sri. Ganesh Chandra Das aged about 48 yrs. S/o. (L) Nagendra Das of New Colony, Tarapur, Part-I, PO & PS- Silchar and Dist.- Cachar, Assam and Sri. Goutam Das aged about 27 yrs. S/o. (L) Surendra Das of Bijoynagar, PO & PS - Ratabari and Dist.- Karimganj, Assam who were engaged in the Railway Track Work at Vangai Chungpao, Manipur were knocked down by one truck bearing registration no. AS11-EC - 3180 while we were standing near the work site at Leishabithol village due to rash or negligent driving on the part of the truck driver. As a result of which my-self along with 2(two) labourers were received serious injuries on our persons and evacuated to Silchar Medical Collage & Hospital (SMCH), Silchar for medical treatment. We are still undergoing medical treatment. As such, the concerned doctor of Silchar Medical Collage & Hospital (SMCH), Silchar who examined us referred to Guwahati Medical Collage & Hospital, Guwahati as the mode of injuries are in serious in nature and it will take more time to recover. More over, it may be mentioned that we all are labourer class persons and as the driver of the said truck had assured us that the owner of the said Truck would bear all the necessary expenses of our treatment and not to file any F.I.R. at P.S, so we could not file the F.I.R. in time.




