

Sir,

With due respect, I beg to report you with reference to the above subject that today i.e. on 19-03-2024 at about 08:00 A.M. one Mutum Biken aged about 45 years S/O not known residence of Gularthol Bazar, Jiribam (Samupunbi) along with one unknown person entered at my house located at Babupara Ward No-5, Jiribam by using a two wheeler scooty bearing regd. No. Not known (white in colour) and forcefully abducted my husband namely Mayajun Laskar (24 yrs.), S/o Late Ajir Uddin from my house and took away by using the same vehicle with the reason best known to them. While my brother-in-law namely, Abdul Laskar was about to report the matter to concerned authority, my own maternal mother who live near Jiri Hospital informed me through telephonic conversation that my husband is brought at Jiri Hospital located at Ningsingkhul, Jiribam in a very critical condition. Then, after few minutes it is further informed that my husband is succumbed due to severe injury on his person.

In the above circumstances, you are requested to take necessary action according to law at the above said culprits from your kind ends.
