

Sir,

I have the honour to report on 18/03/2024 at around 6.30 pm while I along with my wife namely Kh. Nena Devi were ready to have dinner at our house located at Gularthol Thong Wangma, Jiribam, Manipur, meanwhile some unknown persons numbering about 4 (four) belongs to Kuki community were entered inside our house and stood at the Verandah. On seeing them I and my wife immediately came out at the Verandah. Along those two of them were known by me one namely Ruben and one knew by face both from Phaitol village under Tousem Sub-division Tamenglong District, Manipur. One among them forcibly entered inside our house and started looking nook & corner with the best reason known to them. After some time at around 7.00 pm of the same day, all of them fled away towards an unknown direction without saying anything. Being frighten we could not inform to anyone. Later, it is come to notice that a sum of Rs. 50,000/- (fifty thousand) is found missing, which I kept hidden underneath the mattress of our bed. As a result of which we are difficult to stay in our house peacefully.

It is therefore, requested to kindly take up necessary action against the culprits.
