Sir,

I have the honour to reported that, today i.e. 23/04/2024 at around 11:30 am, I along with a team of Leingangpokpi Police Out Post, Jiribam conducted normal frisking and checking at Leingangpokpi Police Out Post gate, Jiribam. During frisking and checking, one person was coming from Jiribam side towards Tamenglong side in a suspicious manner. In that he was stopped for verification. On verification he identified himself as one Lalson (37)yrs S/O (L) Lalkhugin Gangte of Longpi Village, Nungba-Sub Division, Noney District, Manipur.

Further on checking of his carry bag (multi-colour), 1(One) country made Rifle (Buttless) with one magazine, 1(one) Rifle's Butt were found inside the carry bag. On further checking 1(one) Mobile Handset (Vivo) having Airtel and Jio Sim Card and 1(one) money bag containing Rs.13,120/- (Thirteen thousand one hundred and twenty) were also found and the same were seized from the possession of Lalson (37)yrs S/O (L) Lalkhugin Gangte of Longpi Village, Nungba by preparing a formal seizure memo in presence of the witnesses at 11:50 am and he was also arrested at 11:55 am.

Hence, the seized items along with the arrestee are handed over to you for taking further necessary action please.
