Sir,

I have the honour to report that today i.e. 24/04/2024 at around 11.30 am, my team along with representative of Jiribam Police Station carried out a Joint random frisking & checking at Kunjabond along JT Road. In the meantime, at around 12:30 pm, one Bolero Pick up (white colour) bearing regd. No. AS 11DC-3506 which was coming from Tipaimukh, Pherzwal District, Manipur towards Cachar district, Assam through Jiribam was stopped for checking. On checking, 2 (two) persons were found inside the vehicle (including the driver) and checked for verification. On verification, they identified themselves as (1) Abdul Mannan Mazumder (31)yrs S/O (L) Abdul Jalil Mazumder of Ganganagar Part-X, P.O-Kalakhal PS-Sonai, District-Cachar, Assam & (2) Khalil Ulla Barbhuiya (26)yrs S/o Monir Uddin Barbhuiya of Ganganagar Part. xiii P.O-Kalakhal PS-Sonai, District-Cachar, Assam. On further checking of the vehicle, it was found loaded with bananas. On minute and thorough checking, some pumpkins were found concealed inside the bananas and on checking the pumpkins, there were some cut marks over the pumpkins which are suspected to have concealed some contraband items. On checking the pumpkins, 6(six) pumpkins were found containing 5(five) nos. of soap caps each which is suspected to be contraband brown sugar, which were being transported to Assam. All the soap caps containing suspected to be brown sugar were taken out and marked as A-1 to A-30 respectively. Subsequently, all the marked 30(thirty) soap caps were weighed (by using an electronic weighing machine) excluding the weight of the soap caps and found "A-1=11.86 grams, A-2=11.15 grams, A-3=12.17 grams, A-4= 12.58 grams, A-5= 11.24 grams, A-6= 11.45 grams, A-7= 11.06 grams, A-8= 12.00 grams, A-9= 11.40 grams, A-10= 11.60 grams, A-11= 13.46 grams, A-12= 12.85 grams, A-13= 13.15 grams, A-14= 13.34 grams, A-15= 12.24 grams, A-16=12.25 grams, A-17=11.20 grams, A-18=13.17 grams, A-19= 12.60 grams, A-20= 12.75 grams, A-21= 11.70 grams, A-22= 11.58 grams, A-23= 13.40 grams, A-24= 12.30 grams, A-25= 13.00 grams, A-26= 11.14 grams, A-27= 11.50 grams, A-28= 12.23 grams, A-29= 11.50 grams, A-30= 11.58 grams (Total = 363.45 grams excluding the weight of the soap caps)".

Thereafter, all the soap caps containing suspected to be brown sugar i.e., "A-1 to A-30" were put inside a cartoon box and wrapped with plain white cloths and packed & sealed by using wax with a five rupees coin and marked as "P". The same along with involved Bolero Pick up white in colour bearing regd. No. AS 11DC-3506, 6(six) nos. of Pumpkins in which soap caps containing suspected to be

brown sugar were kept concealed and one realme C21-Y mobile handset were seized from the possession of Abdul Mannan Mazumder (31)yrs S/O (L) Abdul Jalil Mzumder of Ganganagar Part-X, P.O-Kalakhal PS-Sonai, District-Cachar, Assam (Driver of the vehicle) at 01.10 pm by observing formalities and one OPPO A16K mobile handset was also seized from the possession of Khalil Ulla Barbhuiya (26)yrs S/o Monir Uddin Barbhuiya of Ganganagar Part. xiii P.O-Kalakhal PS-Sonai, District-Cachar, Assam at 01.15 pm. No civilian witness volunteer to stand as witness on our request. Accordingly, the 2 (two) persons namely (1) Abdul Mannan Mazumder (31)yrs S/O (L) Abdul Jalil Mzumder of Ganganagar Part. x P.O-Kalakhal PS-Sonai, District-Cachar, Assam (Driver of the vehicle) & (2) Khalil Ulla Barbhuiya (26)yrs S/o Monir Uddin Barbhuiya of Ganganagar Part. xiii P.O-Kalakhal PS-Sonai, District-Cachar, Assam were arrested at 01.20 pm & 01.25 pm respectively.

The seized items along with the arrested persons are handed over to you for taking further necessary action.
