



Sir,

I have the honour to report that, I am a Bus driver of the Bus bearing regd. No. MN 01BA- 0185. The said bus has been engaged for transporting CAPF in c/w 18th Lok Sabha Election, 2024. The said bus was parked inside the Jiribam Police Station Campus in front of Police Guest House since 16/04/2024.

Today i.e., 27/04/2024 at around 11.30 am, I went to Jiribam Bazar for marketing and returned back at around 4.30 pm of the same day. Thereafter, I came to know that one 1500 volt Exide battery (black and white colour) which was fitted on the said bus was found stolen away by some unknown person (s). The said unwanted incident may be taken place in between 11.30 am to 4.30 pm of the same day. The approximate value of the said stolen Battery is Rs. 17,000/- (seventeen thousand).

It is, therefore, requested to kindly take up necessary legal action against the culprits.
