



Today i.e. 30/04/2024 at 01:00 pm received an information that on the same day at around 12:40 pm one Tata Truck (6-Wheel) bearing Regd. No. AS01GC-3129 loaded with transport (mix) met an accident at Khridziiphi Village along NH-2 which was coming from Dimapur towards Imphal and fell down at deep gorge due to rash or negligent driving on the part of unknown driver. As the result of which the driver of Tata Truck received serious injuries on his person and helper of the said vehicle was succumbed to his injuries on the spot. The Tata Truck which was loaded with transport items were also badly damaged.
