Subject: report

Sir,

I am writing to report the recovery and subsequent submission of a cache of weapons and ammunitions as part of an operation conducted by a joint team of 16 Assam Rifles and District Police Kangpokpi, in accordance with the specific input received on 29th March 2024.

On the aforementioned date, specific input was shared by intelligent agency regarding the movement of unknown armed miscreants in the general area of Changoubung village approximately 5 Kms North of Changoubung village in Kangpokpi District, Manipur. In response to this information, 22 AR, 16 Assam Rifles, C Coy of 186 CRPF Bn and Kangpokpi Police launched a search operation at 0930 hrs today I.e. 30/03/2024 in the general area Changoubung. During the search operation, the unknown armed miscreants were not found in the area and suspected to be fled away and hideout. On search of the area, the following arms and ammunitions were recovered and seized from the spot at 1215 hours.

- (a) 01x9mm-Pistol(Regd.No-L9355)country-made
- (b) 01x9mm-Pistol-Mag
- (c) 01x 7.65mm-Pistol(RegdNo 9103)
- (d) 01x 7.65mm-Pistol-Mag
- (e) 05 x 7.65mm Live Rds

The recovered arms and ammunition are being handed over to you for further necessary action.
