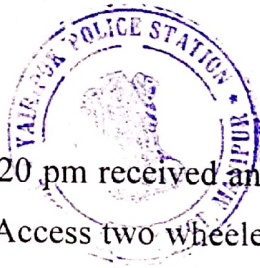



Today i.e. 10/04/2024 at 7:20 pm received an information that on the same day at about 7:15 pm one Suzuki Access two wheeler vehicle, ridden by unknown rider coming from Yairipok Bazar side towards Yairipok Khoirom side along Yairipok Chandrakhong road and one Honda Activa ridden by known rider coming from opposite direction were collided each other at Yairipok Kekru Makha Leikai due to rash or negligence riding on the part of the unknown riders of the both vehicles. Resulting the riders of the two wheeler vehicle and one pillion rider of Honda Activa sustained injuries on their persons and evacuated to the Hospital for medical treatment. The vehicles were also partly damaged.

Hence a sou-motto case under FIR No. 19(04)2024 YPK-PS u/s 279/338/427 IPC has been registered for investigation.
