I am writing to report the recovery and subsequent submission of a cache of weapons and ammunitions as part of an operation conducted by a joint team of 16 Assam Rifles and District Police Kangpokpi, in accordance with the specific input received on 10<sup>th</sup> April, 2024.

Based on the specific input was shared by intelligent agency regarding the movement of unknown armed miscreants in the general area of S. Changoubung village approximately 6 Kms North of S. Changoubung village in Kangpokpi District, Manipur. In response to this information, a joint team of E-Coy, 16 Assam Rifles and Kangpokpi Police launched a search operation from 1205 hrs to 1455 hrs today i.e. 10/04/2024 in the general area of S. Changoubung. During the search operation, the unknown armed miscreants were not found in the area and suspected to be fled away and hideout. On search of the area, the following arms and ammunitions were recovered and seized from the spot at 1455 hours.

- (a) 01 x Baofeng (walkie Talkie) along with Battery.
- (b) 01 x Baofeng Charger
- (c) 01 x empty magazine of 5.56 mm INSAS Rifle
- (d) 01 x 36 Hand Grenade (Defect)
- (e) 01 x 9mm Pistol (Bearing No. Nil) with 1(one) empty magazine
- (f) 02 x live rounds of 9mm pistol
- (g) 10 x 5.56mm live rounds
- (h)  $10 \times 7.65$  mm Pistol live rounds.

The recovered arms and ammunition are being handed over to you for further necessary action.
