Subject: Request to registered FIR for Fire incident at our Site

Respected sir,

This is to inform you that under the guidance CSIR- NEIST Jorhat (Government of India) we are constructing joint research centre for cultivation and extraction facility for medicinal plant at village K.Nungmanbi, Island Sub Division, District Kangpokpi, Manipur which comes under Thoubal Dam Police Station. For the said purpose, the Government of Manipur had issued license for manufacturing and sale of medicine derived from medicinal plant, and also to carry out research on medicinal plant at Manipur.

It is hereby brought to your kind attention that numbers of incident have taken place in the State of Manipur. The same has let to numerous damages of properties and human losses across the state. It is with utter pain we inform you that Indica Nutraceuticals was no exceptional to the same and after the start of this violence. On 20th April 2024 at about 7:00 pm. Around 10-12 unknown people forcefully entered at our site (K. Nungmanbi) and burned generator, ware house, PVC pipes, CCTV recording room where we had server and other electronic items, Police post we have arranged for Police station and Containers for storage, also stolen and taken away many valuable items like iron angel, tin sheets, small DG sets.

The entire incident led to a great financial loses to us. The list of the item stolen and burn are attached with this letter. You are requested to arrest these people and help us to recover the items which they have taken along with them. In case you need additional information please inform us.
