Subject: Report

Sir,

With due respect, I have the honour to report that today i.e. 10/05/2024, a team of Bihar Regiment, lead by company commanders, stationed at Maphou Dam Company Operating Base carried out an recovery operation. The team consisting of strength 02-02-25 from column of BIHAR Regiment along with two teams of CDO-IE posting at Keithelmanbi Post and one team of TBL DAM PS reached at General Area Maphou at 0600 hours to check for presence of telltale signs of any cadre group in the sensitive Zone of Maphou, Kamu Saichang and Fringes of Maphital ridge of Kangpokpi District under the jurisdiction of TBL-DAM-PS, based on intelligence from local sources about likely presence of UG in the area. During the operation, deliberate search of area was carried out which included checking and search of abandoned places and periphery of hill bases and abandoned structures. During the search at under construction structures cordtex was found lying near erstwhile under construction building at Kamu Saichang Village. After deliberate search, war like stores were recovered from nearby places. Details of recoveries are mentioned below :

- I. 40 mm country made gun (3 feet)-02
- II. Pompie mor bomb -21
- III. Cordtex (3 feet)-
- IV. Dynamite gun powder -01 kg (approx)
- V. Pompie amn round cap holder -04
- VI. Ak -47 fired case -06
- VII. 7.62 mm fired case -19
- VIII. 12 bore fired case -01
- IX. Battery cell -01

The above items have been seized in presence of the witness at the spot. Thereafter, the above recovered arms, ammunition and explosives etc which were seized in the above mentioned operation have been handed over to you for taking up further necessary legal procedures.
