Subject: Report.

Sir,

I have the honour to report that today 16 AST 104/2024 at about 5.30 pm, on receipt of a reliable input from own source about the movement of some contraband item in and around YPI bazaar areasand after reducing the source report into writing and after taking due permission from SP-Imphal East. Self along with police team started conducting intensive frisking and checking in front of KVS car wash. In that one person who matches with the input was found proceeding on one black TVS NTORQ scooter from Yaingangpokpi Bazaar towards Gwaltabi side was detained for verification.

Onspot verification, he identified himself as one Ringam Shimray(14) S/O Ringphami Shimray of Crihang Village Ukhrul District, Manipur. PO and PS-Ukhrul. Instantly on learning that the detainee is of Minor aged, immediately informed OC YPI-PS and juvenile welfare officer ASI Suresh Singh of YPI-PS for further proceedings. Further the child welfare officer ASI Suresh Singh child welfare officer further informed DCPO I/E (District child protection officer) and took necessary instruction from her and moreover submitted a requisition to SDO Sawombung to depute one Executive Mgst at the spot for further proceedings. In the meantime Executive Mgst namely RK Gyandeep Singh SDC Sawombung arrived at the spot and the suspect CCL was given a option whether he would like to check his body and belongings in front of Gazetted officer or Mgst. In that he opted to be searched in presence of Executive Mgst. Accordingly the concerned Executive Mgst and one civilian namely Songamchan Shangh 20yrs S/O Onsimus Shangh Mayophung village Mayophung Ukhrul -795142 Manipur who was walking nearby the spot was requested to be civil witnesses during the procedures. Thereafter in front of the Executive Mgst, the CCL body and belonging were searched and on checking his belonging i,e one body side sling black bag, some cash amounting Rs. 79,800/-(seventynine thousand eight hundred) and one mobile phone xiomi 11i and beneath that found kept concealed of two soap case wrapped in black polythene which is highly suspected to be contraband brown sugar.

Immediately, a weighing machine was brought from the nearby locality shop and properly weighed both the soap case which weight 11 grams marked as "A" and 12 grams marked as "B" respectively total weight 23 grams excluding the weight of plastic packet and sealed and packed on a brown envelope at the spot by observing necessary formalities. So, the suspected contraband brown sugar were seized in presence of the Magistrate and civil witnesses at 6:00 pm and one scooter TVS NTORO black in colour bearing regd. Number MN01AL-9409 and one mobile phone with one jio sim card were seized from his possession.

Accordingly, the CCL was apprehended at 6:20 pm from the spot i,e in front of KVS car wash along NH-202 near Yaingangpokpi Bazaar by observing necessary formalities and handed over to Yaingangpokpi Police Station along with the seized items for taking further necessary action.
