Subject: - Report.

Sir,

I have the honour to report today i.e. 24<sup>th</sup> April, 2024 based on a specific input from own sources, a combined teams of District Police I/E comprising of Oscar-12, 14 and 21 of CDO I/E, a team of YPI-PS and one team of 20<sup>th</sup> JAT Regiment led by Sub. Jai Bhagwan stationed at Gwalabi village under the command of Inspt. Kh. Henery Singh OC/CDO I/E under the supervision of Kh. Herojit, MPS Addl. SP(Ops) I/E and overall supervision of Shri. K. Megahchandra Singh, MPS SP I/E conducted search operation at Chanung - Sabungkhok hill ridge areas about 1 km N/W of Sabungkhok village starting from 12.30 pm of the same day.

In the search operation, the following arms, explosives and ammunitions were found hidden at a place in the hill top of Sabungkhok Khunou by some unknown miscreants and the same were recovered with due legal procedures at 01.30 pm.

Particulars of Arms, Explosive and Ammunitions recovered are: -

- (1) 04(four) improvised long range Mortar (pompi).
- (2) 01(one) fired case of improvised long-range Mortar (pompi round).
- (3) 02(two) fired case of Lathode bearing No. 40 mm M 118 CAN-11-1-1-74.
- (4) 01(one) 9 mm pistol bearing No. 5262 along with 01(one) 9 mm pistol magazine.
- (5) 01(one) 7.65 mm pistol bearing No. 116(12)10 F2 CMS along with 01(one) 7.65 mm pistol magazine.
- (6) 01(one) .303 Rifles marked as F2 along with 01(one) .303 rifles magazine.
- (7) 01(one) country made single barrel.
- (8) 02(two) live 9 mm pistol rounds.
- (9) 02(two) live 7.65 mm pistol rounds.
- (10) 30(thirty) live 7.62 mm AK-47 rounds.
- (11) 03(three) number 36 Hand grenades without detonator.

The search operation was concluded at 02.00 pm and the seized items have been handed over to YPI-PS for further legal procedures.
