



That, on 18<sup>th</sup> April 2024 at around 11.45 pm while I was staying at home located at Soibam Leikai near Citizens' Club, opposite Radhe Community Hall, Post Office and Police Station, Porompat, Imphal East - District some unidentified gunmen/gunman fired 2 (two) rounds of bullets to my residence. Such act is against law and highly condemnable. So kindly lodge a case against this inhuman action to me and my family.

It is, therefore, requested that your respected Sir be pleased to register a case against wild actions of firing to my residence as deem fit and proper.
