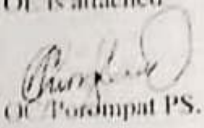

Balraj of Wangkhei Wangm Leikai and their associates inside the booth 14/8, Balwadi School while my brother was on Que for MP Election without giving any reason as a result my brother received injury on his body and evacuated to JNIMS Hospital for medical treatment.
