Sir,

In inviting a reference to the above subject, I am to report that Hon'ble MLA and Nominee of 4-Kshetrigao AC forcefully took away of NFSA rice for the month of March, 2024 from FCI Sawombung depot today at around 4:30 PM.

The rice had been loaded in 9 (nine) trucks totaling a quantity of 1327.40 quintals. But, unfortunately the said incident took place by using unlawful activities in which a large number of his supporters along-with him stormed FCI Depot, Sawombung and overpowered the Official representative of Kshetrigao AC and thereby taking 9 (nine) loaded of NFSA rice by force.

Further, the field report as submitted by the concerned Official representative is also enclosed which is also self-explanatory.

Hence, it is therefore, requested to kindly take up necessary steps for registering an FIR in this regard.
