

Subject : Report.

Sir,

With due regards, I beg to state that today i.e. 12/04/2024 at about 05:30 am received a reliable information that some unknown miscreants have stored some arms, ammunitions and explosives at Yerum Ching under the jurisdiction of NSK-PS.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with COB Somrei, 33 AR 'D' COY, COB Thoubal, 33 AR 'B' COY led by OC/CDO-TBL and a team of NSK-PS under the command of Shri H. Devendra Singh, MPS, Addl. SP(Ops)/TBL and under the overall Supervision of Sr. SP/TBL have rushed to the spot immediately and launched a massive operation at 06:15 am by using metal detectors. On searching and found the undernoted articles i.e. 1) 1 (One) no. of SBBL (bolt action), 2) 1 (One) no. of SMG Carbine bearing Reg. no. 15506435 along with magazine, 3) 1 (One) no. of Pistol along with magazine, 4) 4 (Four) nos. of 51 mm mortar bomb, 5) 8 (Eight) nos. of 36 HE hand grenade (can be used as explosives), 6) 3 (Three) no. of Tear Smoke Shell (soft nose) 7) 1 (One) no. of IED, 8) 1 (One) no. of Walkie-Talkie 9) 2 (Two) nos. of Tear Smoke Shell, 10) 1 (One) no. of Dye Marker Grenade with irritant anti-riot, 11) 2 (Two) nos. of Cartridge 38 mm Anti-Riot with Rubber Bullet, 12) 13 (Thirteen) nos. of 9 mm ammunition 13) 1 (One) no. of Combat helmet, 14) 1 (One) no. of SLR magazine and 15) 1 (One) packet of CAT II 83 mm Explosives have been seized from the spot at 07:48 am. The massive searched Operation was conducted from 06:15 am and continue till 09:00 am of the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
