

Sir,

I have the honour to inform you that I am permanently residing at Salam Patong Village however myself and family members mostly resided at my residential house located at New Lambulane, 2<sup>nd</sup> street, Imphal East. My residential house and properties at Salam Patong Village were being look after by my relative. Unfortunately, unknown miscreants suspected to be Arambai Tenggol and Meitei Leepun suddenly attacked our village on 04/05/2023 and all the villagers left the village for saving their life from the attack of the Meitei miscreants. So, our residential house along with all household properties were left behind unattended.

That, I came to learnt in the 1<sup>st</sup> week of January, 2024 that my Paddy Field under (1) Dak No. 145, Patta No. 273(Old) & 231 (New) (2) Dak No. 147, Patta No. 130(Old) & 151(New) and (3) Dak No. 145/143, Patta No. 274(Old) & 150 (New) located at Mayai Keithel/Komlaching under ~~NSK~~ Police Station, Thoubal District was illegally /criminally trespass and utilized for stone query by unknown miscreants suspected to be Meitei community.

It is therefore requested to take up a necessary legal action according to law.
