Sir.

I am report that today 29<sup>th</sup> April 2024 at around 0500 am received a credible information from 37 AR about presence of some members of banned outfit organization KCP and they are loitering in and around near Khongjom War Memorial area of Thoubal District. On received the input I along with a column of 37 AR, COB Kakching and a team of CDO unit Thoubal led by Hav. Rambai under the command of Inspt.K. Nitaranjan OC/CDO Unit, rushed to the said area and conducted frisking and checking at 0610 hrs. near Khongjom War Memorial gate. During the course of frisking and checking one unknown person was spotted coming by foot in very suspicious manner. On his suspicious mannerism, he was detained for spot verification.

On verification, he identified himself as SS Capt. Wangkhem Premjit @ Kamcha Singh aged about 44 yrs. S/o W.Deva Singh of Luker Mayai Leikai, PO & PS Patsoi, Imphal West District, Manipur. On body search recovered 1 (one) 9mm Pistol along with 3 (three) rds. from his possession and seized the items at the spot at 0615 am. Further questioning he disclosed that he joined KCP in the years 2023 of the said outfit and he was trained at Kameng Sabal, Basic military training (Phumlou) under Army No. 1040 and holding the rank of S/S Capt. (KCP) finance. He also stated that he worked under the command of Yambung Awangba (KCP) Lamyanba Khuman and he also admitted that he is involved in extortion of money for the party fund from general public, businessmen, Govt. department and shopkeepers of Thoubal District. Thus, from the above fact and circumstances, he was arrested from Khongjom War Memorial gate at around 0620 am by observing formalities.

Therefore, the arrested person, along with arrest memo and the seized article are handed over to you for taking further necessary legal action against him.
