Respected Madam.

With due respect and humbly. I the undersigned submit few lines for your kind perusal and necessary action according to law

That, on 10-4-2024 at around 10:30 nm, I along with my husband went to Hospital for checkup of the health condition of my husband. On the way at Iroipat Thoughhoug in the front of Moijing Oil Pump, I and my husband seen that the head of my son namely Md. Rohit was severely attacked with a sword by the Accused persons namely (i) Md. Yashin, aged about 55 years, S/o not known to me, (ii) Md. Hazikhan, aged about 25 years, S/o Md. Yashin and (iii) Md. Rahul, aged about 22 years, S/o Md. Yashin of Moijing Iroipat, PO & PS Thoubal, District Thoubal, Manipur by holding deathly weapons like sword. iron pipe etc.

Then, I and my husband namely Md. Ayub Khan tried to pacify and stop the said incident but the Accused Persons mentioned above assaulted with intent to outrange my modesty and voluntarily caused grievous hurt to me by using dangerous weapons i.e. swords, iron pipes etc. Thereafter, the local people intervened the said incident. Immediately, my husband took to Noor Hospital by my uncle namely Md. Mahamud for my treatment. Thereafter, I was advised by the consult doctor to a well equipment hospital for my further treatment. As such, I admitted to the Dispur Hospital, Guwahati.

Then, the accused persons extorted a Honda Activa (4G) Regd. Nil, Engine No. 50 ET 5584479, Chassis No. ME 4JF 507 JHT 584114 from my son. And, the accused persons extorted a sum of Rs. 7,000 - (Rupees seven thousand), one Mohor of Gold and a bundle of key were extorted from me by assau ting me causing grievous hurt.

That, I could not report/complaint in time before the Respected Madam/P.S. concerned for taking actions against the accused persons as I was out of station at Guwahati for my medical treatment.

In the above facts and circumstances, it is therefore prayed that the Respected Madam may kindly be pleased to take up legal actions against the accused persons and punish them according to law for the POLICE De of justice.
