I the undersigned would like to state few lines before your kind consideration and sympathetic action. That we were staying in a rented house belonging to one the Muslim community at KEKRU VILLA, NORTH AOC, IMPHAL EAST. But on 4Th May Around 12:30PM We had to leave our homes due to prevailing law and order situation and we were compel to take shelter at 2nd M.R Battalion till 8th May 2023 afternoon after which we were escorted till Kangpokpi by the A.R personal .By the grace of God we were inform by our neighbour that our property are all safe till 2nd February 2024 however on 4th April 2024 I came to learnt through one of my neighbor that all my household properties were looted by some unknown miscreants. The exact date and time of the incident could not be ascertained however suspected to be happening during the 1st week of April 2024.
