Sir,

With due respect, I have the honour to report that on 10<sup>th</sup> April, 2024 at @ 05.00 PM, my daughter namely Wahengbam Kalpana (21 yrs) went to Keishamthong Market, Imphal to buy some vegetables and fish in one Honda Activa Yellow color bearing registration No. MN01AE-5015 and, while she was buying some fish at Keishmathong Market suddenly she was overpowered by one Ngangom Raju (24 yrs) S/O Ng. Bhogen Singh of Kangchup Sanjenbam Mayai Leikai, Imphal West District along with two unknown persons who came on one Royal Enfield (Bullet), and the said Ngangom Raju forcibly took her in the Honda Activa to an unknown paddy field by driving around one hour. They threatened her and physically assaulted by Ngangom Raju, and stayed at the paddy field for about two hours. Later on, they took her inside the house of the aunty of Ngangom Raju at Kangchup Sanjenbam Mayai Leikai, Imphal West District and she was kept inside one room locked from outside. Next day i.e 11<sup>th</sup> April, 2024 my daughter was brought to our house by the family members of Ngangom Raju and stating that she was eloped by Ngangom Raju.

It is therefore, requested your good self to kindly take up necessary legal action against the above-mentioned culprits in the interest of natural justice.
