I have the honour to state that during the course of enquiry of GD No. 17/GSPM-PS/2024, dated 17/02/2024. That Mr. Ngamkholun Haokip (47) S/o. (L) Paojang Haokip of Satang Kuki, under Sagolmang P.S. Kangpokpi district submitted a complaint report to OC/GSPM-PS on 17/02/2024 that his daughter namely Hoineilam Haokip (25) who was staying at Haokip Veng, Imphal East district was found missing since 06/05/2023 and hectic efforts have been made to find her by searching suspected location but all efforts gone in vain and her whereabouts is not known till date.

Accordingly, a WT message vide No. 15/G-SPM-PS/2024 dated 17/02/2024 was sent to all OSC in Manipur to make a sharp look out of the missing person namely Hoineilam Haokip, D/o. Ngamkholun Haokip of Satang Kuki, KPI district who was staying at Haokip Veng Imphal East district was found missing since 06/05/2023 and her whereabouts is not known till date and to kindly intimate if found.

As per endorsement, on 23/03/2024, I enquired into the matter by examining the complainant Mr. Ngamkholun, thoroughly and recorded his statement who fully corroborated with the report. Further, recorded the statement of Mr. Ngampao Haokip (39) S/o. (L) Shemkholun Haokip of Lailoiphai village, CCP district at present residing at Haokip Veng, Imphal east district and recorded his statement. In that, the whereabouts of the missing girl Miss Hoineilam Haokip is still untraceable till date in spite of their hectic efforts. Both the complainant and the witness assert in their statements that the missing girl namely Miss Hoineilam Haokip might have been suspected to be kidnapped by Meitei radicals like Arambai Tenggol, Meitei Leepun or other extremist volunteers on the day which Haokip Veng, Imphal East was attacked on 04/05/2023.

In view of the above facts and circumstances revealed during the course of enquiry a case for the commission of offences U/S. 365/367/120B/34 IPC was found suspected.

It is therefore, requested to register a regular case against the unknown aforementioned persons for a thorough investigation in order to trace out the Missing person.




