No. Nil coming in opposite direction at Khurai Chingangbam Leikai near NESU ground gate due to rash and negligent driving on the part of the both unknown drivers. As a result of which, one female occupant of the Hyundai i10 car and the rider along with two pillion of Honda Dio received injuries on their persons and evacuated to nearby Hospital for medical treatment and also both the vehicles got damaged.

Hence a regular case under FIR. No. 257(04)2024 PRT-PS. u/s 279/338/427 IPC has been registered on suo motto for investigation.

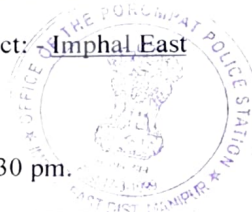




