Today i.e 14/04/2024 at about 2:10 pm when I was in my office room, received a specific input that some illegal contraband substances are kept concealed at the house of Md. Farid Khan (39) yrs s/o Mv. Taher Ali of Lilong Yangbi Leikai for wrongful gain. Accordingly, after verifying the veracity of source report, the information was taken down in writing and a copy of the same was forwarded to Sr. Superintendent of Police, Thoubal for information and further necessary action. Accordingly, I obtained the search authorization from the Sr. Superintendent of Police, Thoubal. Immediately, a combined team led by SDPO/TBL, self and including women police and a team of Commando Lilong led by Jem Md. Amin Khan JC No. 843 of 7-MR now attached with CDO Unit Thoubal of CDO Unit Thoubal under the command of Shri N. Suraj Singh MPS, Addl. SP (I&O), Thoubal, Shri H. Devendra Singh MPS, Addl SP (OPS), Thoubal and under the supervision of Sr. SP/TBL, Thoubal and under the with necessary procedure rushed to the residence of Md. Farid Khan (39) yrs s/o Mv. Taher Ali of Lilong Yangbi Leikai at around 2:40 pm. On reaching the spot, our police party have rushed at the said residence and no one seen in the house but only one individual in suspicious manner and we realized that she is the mother of Md. Farid Khan (36) yrs s/o Mv. Taher Ali of Lilong Yangbi Leikai, but she is under treatment. Thereafter, our combined team conducted concrete search at the premises of the house of Md. Farid Khan (39) yrs s/o Mv. Taher Ali of Lilong Yangbi Leikai in presence of independent witnesses and Gazetted Officer by observing formalities

On searching the said house, our teams found one black colour plastic polythene with contained 6 (six) boxes labelled as SEMPLEX+ capsules (Dicylomine Hydrochloride, Tramadol Hydrochloride & Acetaminophen capsules) among the 6 (six) 2 (two) are empty, 7 (seven) bottles of cough syrup labelled as Codeine Phosphate & Triprolidine Hcl. Syrup and 9 (nine) empty bottles of cough syrup labelled as Chlorpheniramine Maleate & Codeine Phosphate syrup NCODE-CM (8 bottles) and Codeine Phosphate & Triprolidine Hcl. syrup A-CARE (one bottle) were found concealed inside the wooden Almirah which place inside the drawing room. On opening the boxes contained six long stripes each boxes and total pieces of Simplex capsules is 576 pieces. And the 7 (seven) bottles of cough syrup marked as Chlorpheniramine Maleate and Codeine Phosphate syrup NCODE-CM contain 100 ml each.

On further the 4 (four) boxes labelled as SEMPLEX+ capsules (Dicylomine Hydrochloride, Tramadol Hydrochloride & Acetaminophen capsules) which contained capsules were put into a cartoon box and covered with white cloth marked as "A". And the 7 (seven) bottles of cough syrup labelled as Codeine Phosphate & Triprolidine Hcl. Syrup which contained syrup were put into a cartoon box and covered with a white cloth marked as "B". The remaining 2 (two) empty boxes labelled as SEMPLEX+ Capsules (Dicylomine Hydrochloride, Tramadol Hydrochloride & Acetaminophen capsules) and 9 (nine) empty bottles of cough syrup labelled as Chlorpheniramine Maleate & Codeine Phosphate syrup NCODE-CM (8 bottles) and Codeine Phosphate & Triprolidine Hcl. Syrup A-CARE (one bottle) were put into a cartoon box and marked as "C" in front of the Gazetted Officer and seized by observing formalities in presence of witnesses at 03:30 pm by preparing a formal seizure. In that the individual namely Md. Farid Khan (39) yrs s/o Mv. Taher Ali of Lilong Yangbi Leikai was not found at his house.

In that request to the neighbors to put their signatures as witnesses but no one is turned up to put their signature.

It is therefore, the seized items are being handed over to you for taking further necessary legal action.
