Sir.

I have the honour to state that on 15/04/2024 at about 04.30 am received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunition and explosive in the Waithou Khongnang Kachin near abandoned but (likely hideout) cemetery of Waithou Chiru tribe.

On received of the information, special operation group (SOG) Thoubal Districts Police along with COB Lilong 33 Assam Rifle, Adhoc M&C-V led by OC/CDO-TBL and OC Lilong PS under the supervision of Addl. SP(Ops) TBL and under the overall supervision of Sr. SP Thoubal have rushed to the spot immediately and launched a massive search operation at 05:00 am by using metal detectors. On searching, found the undernoted arms and explosive items i.e. 1) 01(one) no. of SMG Carbine bearing Regd. No LL6271, 2) 01 no. of Single Barrel, 3) 01 (one) no. of INSAR Rifle bearing registration No. 16655942 and bud No. TS3, 4) 03 (three) nos. of 36 HE Hand grenade and 5) 05(five) nos. of 303 live round respectively from the spot and the same have been seized at 5.55 am by observing formalities. The massive search operation was conducted on the same day from 05:00 am to 07:15 am.

It is therefore, handed over the seized incriminating articles to you for further necessary legal action.
