

I have the honour to report that on 10/4/2024 at about 10:30 am, the following 5 (five) individuals had physically assaulted my father Md. Yashin Khan 62 yrs s/o late Md. Mani Khan of Moijing Lamkhai near Iroipat, Thoubal District using sharp object that was took place at my house premises itself without valid reason.

They are :

1. Md. Ayub Khan aged about 45 yrs s/o Md. Nahaton
2. Md. Arish aged about 21 yrs s/o Md. Ayub Khan
3. Md. Ruhit Khan aged about 19 yrs s/o Md. Ayub Khan
4. Mrs. Mina aged about 35 yrs w/o Md. Ayub Khan
5. Md. Ithem aged about 35 yrs s/o Md. Nahaton

all are residents of Moijing Chingya Leikai near Co Palli

As a result of it, my father sustained severe bleeding injury on his back and taken to District Hospital Thoubal and referred to RIMS Lamphel for further treatment. I could not report in time while I myself along with my family members was attending hospital.

It is therefore, requested to take up necessary legal action in this regard.
