Sir,

With due respect, I have the honour to state the following few lines that, I have running a rented house at Leimakhong Bazar, Kangpoki District Manipur.

That, on 14<sup>th</sup> March, 2024 received telephonic information from my Nepali localities stating that on the same day at around 3:00 pm, some unknown armed miscreants suspected to be Kuki militants who came in a Tata Saktiman had looted many items from my rented house and tenant's valuable properties after breaking the doors.

The properties that were looted is as follows-

1. Medium bed (6 numbers) – Rs 10,000 x 6 = Rs 60,000/-
2. One Texmo Half Hotspower Motor - Rs 15,000/-
3. Four Syntax 1000 Liter (Rs 6000 x 4) = Rs 24,000/-
4. Two Syntax 500 Liter (Rs 3000 x 2) = Rs 6,000/-

Grant total approximate value = Rs 1,05,000/-

Regarding the matter I couldn't report timely to your good office due to lack of legal knowledge.

It is, therefore, requested you to kindly take up necessary legal action please.
