Sub: Complaints regarding attempted assault and threat to my family and damaged to my house and properties by (1) Nurjuman Shah (62)yrs S/o. Late Md. Fajur Rahaman (2) Tahera Bibi (50)yrs W/o. Nurjuman Shah (3) Shakil Ahamed @Boycha(28) S/o. Nurjuman Shah, (4) Wakil @ Captain (26)yrs S/o. -do- and (5) Nasir Hussain @Shamu (24) S/o. -do- all are residence of Moijing Khong Manung and their party.

Sir,

I have the honor to bring the following matter to your attention a serious incident that took place on April 19, 2024, involving an attempt on my life and the safety of my family. My name Muhibur Rahman, age about 74years residing in Moijing Khong Manung.

This morning, around 08:30 am, I went to visit my ailing elder. Upon walking in road in front of his house, one person namely Nurjaman Shah confronted me, wielding a spade and shouting threats to kill me. Fearing for my life, I quickly left the scene and returned home.

Later, my children asked Nurjaman and his family to understand the reason for his aggressive behavior and urge them to remain. Instead of calming down, Nurjaman, along with his wife named **Tahera and their Sons named Shakil Ahamed (Boycha), Wakil (captain) & Nasir (Shamu)** and others team came to my house armed with weapons, threatening seriously injury and death. During their attacks, they caused damage to my house, properties and security cameras. They also threatened us if we come out from our house. We fear that they may return to harm us further and potentially kill us.

Given the gravity of the situation, I urge you to take legal action against Nurjaman shah and his family members mentioned.

Thank you for your prompt attention to this matter.
