Sir,

With due respect, I have the honour to state the following few lines that, I along with my family members are staying at the rented house located at Leimakhong Bazar run by one Khangembam Damo Singh, 72 yrs S/o Late Kh. Methon Singh of Khurkhul Awang Leikai since last 15/16 years back. However on 3/5/2023, I along with my whole family members had left the said rented house after proper locked & key due to fear & safety of our life in c/w ongoing ethnic violence in the state starting from 3<sup>rd</sup> May, 2023.

That, on 14<sup>th</sup> March, 2024 received telephonic information from my Nepali localities stating that on the same day at around 3:00 pm, some unknown armed miscreants suspected to be Kuki militants who came in a Tata Saktiman had looted many valuable household properties from my rented house after breaking the doors.

The properties that were looted is as follows-

1. One Godrej Almirah (4 door) – Rs 27,000/-
2. One Godrej Almirah (2 door) – Rs 15,000/-
3. One glass door almirah ( 2 door) – Rs 17,000/-
4. One almirah (2- face) – Rs 15,000/-
5. One double bed – Rs 20,000/-
6. One medium bed – Rs 15,000/-
7. One single bed – Rs 12,000/-
8. One dining table – Rs 18,000/-
9. One washing machine – Rs 16,000/-
10. One freeze- Rs 22,000/-
11. One Wooden kitchen Almirah – 18,000/-
12. One Philips TV Flat 35 inch – Rs 35,000/-
13. One Dressing table – Rs 8,000/-
14. Four steel trunk – (Rs 5000x 4) = Rs 20,000/-
15. One oven – Rs 6000/-
16. One sofa set – Rs 19,000/-
17. Two gas stove – Rs 10,000/-
18. Two gas cylinder – Rs 4000/-
19. One stand fan – Rs 3000/-
20. One computer table – Rs 3000/-
21. One computer set – Rs 35,000/-



- 22. One woofer speaker – Rs 12,000/-
- 23. One Inverter battery – Rs 19,000/-
- 24. Two syntax (300 liter) – Rs 4000/-
- 25. Two syntax (500 liter) – Rs 7000/-



Grant total approximate value = Rs 3,80,000/-
