Sir,

With due respect, I have the honour to state the following few lines that, I am running one electronic Shop namely "Sky Electronics & Servicing" at the rented shop owned by Heikham Ibohal Singh of Khurkhul Makha Leikai located at Leimakhong Bazar since last 18/19 years back. However my shop was closed under proper locked & key since 3/5/2023, due to fear & safety of life in c/w ongoing ethnic violence in the state starting from 3<sup>rd</sup> May, 2023.

That, on 14<sup>th</sup> March, 2024 received telephonic information from my Nepali localities of Leimakhong Bazar stating that on the same day at around 3:00 pm, some unknown armed miscreants suspected to be Kuki militants who came in a Tata Saktiman had looted many electronic items from my shop after breaking the locker of the door. The approximate value of the looted electronic items is estimated about Rs 13,73,540.00/-

Regarding the matter I couldn't report timely to your good office due to lack of legal knowledge.

It is, therefore, requested you to kindly take up necessary legal action please.
