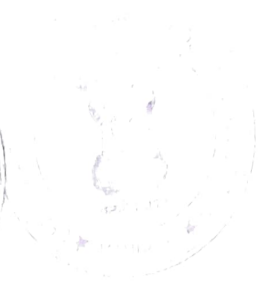

Sir,



I have the honour to report that on 22/04/2024 at around 9:00 pm around 5/6 unknown masked men wearing black colour clothes possessing firearms forcefully entered inside our house who came in two Maruti Van bearing registration No. not known and abducted my son namely Leishangthem Dhananjoy Singh (41) yrs S/o L. Yaima Singh of Leishangthem Awang Leikai. Immediately, they left our house along with my abducted son being boarded in the said Maruti Van towards Mayang Imphal side and whereabouts of him could not be ascertained. Thereafter, my son was released at Irong Chesaba Bridge on the same day at around 11:55 pm with some injury marks on his body which is suspected to be physically assault by the above unknown persons and evacuated at Thoubal District Hospital and further to Shija Hospital, Langol, Imphal West due to seriousness of his injury. I could not report in time due to my son's hospitalization.

It is, therefore, requested to kindly take up necessary legal action.
