Sir,

With due respect, I have the honour to state the following few lines that, I along with my family members are staying at the rented house run by one Khangembam Khangembam Rajeshor of Khurkhul Awang Leikai located at Leimakhong Bazar since last 9 years back. However on 3/5/2023, I along with my whole family members had left the said rented house after proper locked & key due to fear & safety of our life in c/w ongoing ethnic violence in the state starting from 3rd May, 2023.

That, on 14th March, 2024 received telephonic information from my Nepali localities stating that on the same day at around 3:00 pm, some unknown armed miscreants suspected to be Kuki militants who came in a Tata Saktiman had looted many valuable household properties from my rented house after breaking the doors.

The properties that were looted is as follows-

1. One Double bed – Rs 35,000/-
2. Three Medium bed- (Rs 12,000 x 3) = Rs 36,000/-
3. One Study table – Rs 8000/-
4. 5 chair – Rs 4500/-
5. Two Almirah – Rs 30,000/-
6. One Iron godrej- 20,000/-
7. Two gas box – Rs 14,000/-
8. 5 stool –Rs 25,000/-
9. One medium LG freeze- Rs, 13,500/-
10. One washing machine (Samsung) – Rs 14,500/-
11. 3 gas cylinder – Rs 12,000/-
12. Gas frame – Rs 2000/-
13. Pressure cooker 2 – Rs 4000/-
14. Rice cooker 2 – Rs 4000/-
15. Fry pan 2 – Rs 1000/-
16. Khang 1 – Rs 1500/-
17. Dinner set –Rs 2800/-
18. Brite 100 liter (2) – Rs 2400/-
19. Water filter 1- Rs 1400/-
