Sir,

With due respect, I have the honour to state the following few lines that, I am running one rented house at Leimakhong Bazar since last 19/20 years back. However my rented house was closed under proper locked & key since 3/5/2023, due to fear & safety of life in c/w ongoing ethnic violence in the state starting from 3rd May, 2023.

That, on 14th March, 2024 received telephonic information from my Bengali localities stating that on the same day at around 3:00 pm, some unknown armed miscreants suspected to be Kuki militants who came in a Tata Saktiman had looted many valuable household properties from my house after breaking the doors.

The properties that were looted is as follows-

1. Six Bed - Rs 50,000/-
2. Two syntax- Rs.11,000/-
3. One Texmo Half Horsepower Motor- Rs15,000/-
4. 2 coil Pipe- Rs. 4,500/-
5. 2 wooden table - Rs. 1,100/-
6. Four plastic chair- (Rs. 250x4)=1000/-

Grant total approximate value = Rs 82,600/-

Regarding the matter I couldn't report timely to your good office due to lack of legal knowledge.

It is, therefore, requested you to kindly take up necessary legal action please.
