With due respect, I have the honour to state the following few lines that, I am running one rented electronic shop at Leimakhong bazar owned by Louriyam Rakesh of Khurkhul since last 18/19 years back. Due to the ongoing communal crisis, I had locked my rented electronic shop on 03/05/2024 and fled away from my rented shop.

That, on 20<sup>th</sup> March, 2024 received a telephonic that on the same day at around 2:45 pm ~~some unknown~~ armed miscreants suspected to be kuki had looted many electronic items from shop. The approximate value of the properties that were vandalized & looted is about Rs. 11, 27,160/- (Eleven lakh twenty seven thousand one hundred sixty) only.

Regarding the matter I couldn't report timely to your good office due to lack of legal knowledge. It is, therefore, requested you to kindly take up necessary legal action please.
