Sir,

I am writing to file a formal complaint/report regarding the registration of an FIR against me and my family despite being the victim of a provocation, verbal abuse and threatening to kill me with gun.

On 19/04/27, I was subjected to verbal abuse and threats of physical harm by Maibam Albin Rahman aged about 35 yrs. S/o Maibam Rahman at resident of Moirang Warymat Khongmaning P.O x P.S. Thoubal, Thoubal dist. Manipur. The incident occurred when my son Nashir Hameed and I were at my residence. He (Albin Rahman) confronted me and began hurling abusive language provoking a physical altercation, even using a gun entering and standing near the pond of my residence with him. Aitlio Wahidun Rahman aged about 32 yrs.

To, my shock and dismay, I recently learned that an FIR has been registered against me in connection with the incident. This false accusation not only misrepresents that event took place but also undermines my rights as a law abiding citizen. I strongly believed that Maifam Aibun Rahaman is manipulating the situation to evade accountability for his own misconduct.

I urge the authorities to conduct a thorough investigation into this matter and consider the evidence supporting my innocence. I am willing to provide any necessary testimony, witnessed, or evidence to support my claim. It is imperative that justice is served and the true perpetrator of this allegation is held accountable for their action.

I trust that police will uphold fairness and integrity in handling this matter.
