On approaching the nearest Police Station where I was displaced, I was denied to register an FIR and rather advised me to approach your esteem Office for the same to register an FIR in the District which is accessible to me when I am in favourable condition to visit and do the same.

As such, I pray your kind self to condone the delays in filling an FIR till date due to the above cited reason and condition.
