G. Saparmeina Police Station Kangpokpi District, Manipur Today, i.e. 24/4/2024 at 12:10 am, a loud explosive sound was heard in General area of Saparmeina area. Acting upon the incident, Self (ASI Isaac Kilong) along with Quick Reaction Team of Gamnom Saparmeina Police Station rushed for enquiry at Saparmeina Bazaar area and found that the Bridge along NH-2 between Koubru Leikha and Saparmeina Bazaar was found damaged due to the suspected high IED explosion resulting to damaged of the bridge with three holes and some portion of both sides concrete walls and less safety for the vehicle plying along the NH-2. The unknown miscreants who triggered the Bomb had escaped before the Police team arrived taking advantage of the darkness and nearby hills. Further search operation has been conducted within the said areas.
