In inviting reference to the above subject matter, I have the honour to report you that there was a report of theft on 26-04-2024 from Heavy Fuel Based Power Plant (HFBPP), Leimakhong, MSPCL where some sections of pipeline connecting the main tank and pump room has been found to be completely cut off by miscreant and missing during the routine check by MSPCL staff and IRB personal. That on 23-04-2024 there was also the incident where main supply pipeline of HSD connecting the valve and main tank was found to be cut with hacksaw blade. The pipeline was wrapped with rubber tube and ½ inch cut was observed on the pipeline from where HSD oil was found to be leaking and a sign of theft was observed in the vicinity. The photo copies of the incident is enclosed herewith.
