Respected Sir,

I, Lhingneihoi Khongsai aged about 22 years, W/O Paogouhao Tuboi a resident of Gamgiphai village, P.O. Motbung, P.S. Gamnom Sapormeina, Kangpokpi District, Manipur, currently seeking refuge at the Chalwa Relief Camp, Kangpokpi District, Manipur. I am writing to bring to your notice that since 3<sup>rd</sup> May, 2023, a Meitei mob, purportedly associated with Arambai Tenngol and Meitei Leepun attached my village, attempting to set it ablaze. The situation escalated on May 3<sup>rd</sup>, 2023, when my village were heavily attacked that forcing my family and fellow villagers to flee for our lives and seek shelter in the jungle. Through divine providence, we reached Chalwa Village on May 6<sup>th</sup>, 2023, where we were aided by some CSOs/NGOs in registering at the Chalwa Relief Camp, on 6<sup>th</sup> May, 2023.

During this tumultuous period, I was two months pregnant (died before delivery). However, upon reaching the Chalwa Relief Camp, I was not feeling well and when I underwent a medical examination at the PHC, T.Vaichong which revealed that I had suffered a miscarriage due to the profound mental trauma inflicted by the ongoing conflict. *Enclosed herein are the medical documents verifying this diagnosis.* The loss of my unborn child has taken a significant emotional toll on me, compounded by the distress of being displaced and without a home.

Given these circumstances, I urge your esteemed office to take swift legal action against the perpetrators to ensure justice is served. As an internally displaced person grappling with emotional trauma, I was unable to report the incident promptly.
