Sir,

With due respect, I have the honour to state the following few lines to take up a regular FIR in c/w the missing of my elder brother Khangenbam Apamba Singh, aged about 48 yrs S/O Khangenbam Herachandra Singh a resident of Thangmeiband Khomdram Selungba Leikai, P.O & P.S-Imphal.

That on, 19/04/2024 at around 02:30 PM my elder brother Khangenbam Apamba Singh, aged about 48 yrs S/O Khangenbam Herachandra Singh a resident of Thangmeiband Khomdram Selungba Leikai, P.O & P.S-Imphal went out from our residence in his Honda Activa, White in colour bearing Regn No. MN01F-0981 without giving any information to our family members and did not turned up till date. That, it has been ascertained that my brother Khangenbam Apamba Singh was seen driving towards Kanglatongbi side along NH-02 in his Honda Activa, white in colour bearing Regn No. MN01F-0981 on 19/04/2024 as per the CCTV footage installed at Sekmai Police Station. It is highly suspected that my elder brother namely Khangenbam Apamba Singh was kidnapped or abducted by unknown Kuki miscreants from the NH-2 after crossing Kanglatongbi area in order to murder or with an intent to wrongfully confine. We have published/circulated the missing report in the face book also by giving two phone numbers i.e 8787691650 and 7629835379 to give information's about the missing person. But unfortunately we have been receiving threatening calls from different phone numbers of Kuki miscreants i.e 7085631065, 7085790440, 6009378430, 9362086290, 9863900857. The unknown callers (Kuki miscreants) threatened that my brother was intercepted from the Kuki area after crossing Kanglatongbi, he is no more and he will not return back home, and not to wait for him. The whereabouts of my brother is still unknown.

It, is therefore requested your good self to kindly take up a regular FIR for investigation against the unknown Kuki miscreants and to take up further necessary legal proceedings at the earliest.
