Today i.e. 19/04/2024 at @ 02:58 pm received a reliable information that on the same day at @ 02:50 pm one Honda Activa light bluish in colour bearing Regd. No. MN01AB-3717 ridden by an unknown rider plying from Sora side toward Khongjom side along NH No. 102 was dashed by one unknown Diesel Auto plying from same direction driven by unknown driver due to rash and negligent driving on the part of unknown Diesel Auto near Slopeland Public School along NH No. 102. As a result of which the unknown rider and 3 (three) pillion rider including their two children of Honda Activa received injuries on their persons and evacuated to District Hospital, Thoubal for medical treatment. Whereas the unknown Auto has fled away by taking advantage of sparsely populated spot. And the vehicle Honda Activa was partly damaged
