With due respect, I have the honour to report that my daughter namely Rahina (20)yrs was eloped by one Md. Sahid Khan (22)yrs S/o. Md. Ibothem of Lilong Litan Makhong in the month of December 2023 to be his wife. After staying 20(twenty) days at the house of the said Md. Sahid Khan my daughter came back to my house as accompanied with the relatives of the said Md. Sahid Khan and staying at my house. On 10/04/2024 at about 5.40pm the said Md. Sahid Khan, Md. Anish Khan (22)yrs S/o. Md. Abdur Rahim of Lilong Litan Makhong and one unknown person came at my house and suddenly the said Md. Sahid Khan started beaten me asking to produce my daughter Miss Rahina. The said Md. Anish Khan threatened me by showing one small arm. Due to frighten, I got alarmed and the villagers the said persons ran away. Later I got treatment at the clinic of Dr. Md. Basir of Lilong.

It is requested to kindly take up the necessary legal action against the above noted accused for end of justice.
