Respected Sir,

I beg to state that last night 14<sup>th</sup> April, 2024 around 8:30 to 8:58 p.m two (2) un-known persons with small arm fired two (2) rounds at two water tanks kept near the courtyard close to a window of my house after asking whether I am at home, without any valid reason but no casualties in the families. They ran after firing the shots. During the incident I was not in the house. Two round empty cases were found lying on the courtyard and top of the van parked inside the courtyard also two projectiles inside the water tank.

There is no such previous incident, no threat, no money demand in the past. I am just working for local Club (Brawny Club) Lairenjam Leirak Keli Makhong, Imphal West-795001 as General Secretary and Convenor, Sagolband Apunba Lup(SALUP), a joint Club and Meira Paibies organization of Sagolband Constituencies.

I am doubtful whether it may be related to the meeting resolution that was taken as follows: On date 7<sup>th</sup> April, 2024(Sunday) a joint meeting was held regarding the upcoming Lok Sabha Election and a resolution was taken that "the upcoming Lok Sabha Election must be free and fair election under the guidance of Election Commission of India (enclosed resolution copy for reference)".

In this regard, I am to request you to kindly take up necessary appropriate legal steps against this incident and stop such occurrences inside a residential area in the future and to show the law of the land.
