Sir,

I have the honour to report that on 11/4/2024 at about 7:30 pm my son Md. Irshad Ali (18 Years) and his friend namely Md Mustamad (15 Years) S/O Md. Ahamad Ali of Keirao Makting Mayai Leikai were assaulted by the undernoted miscreants by holding deadly weapon like dao, stick and stone in their hand while my son and his friend Md. Mustamad were sitting at the paddy field of Khabam Palli, Keirao Makting Sabal Maning without giving any reason. As a result of which my son and his friend received serious injury on their nose, head, forehead, buttock and chest and evacuated to PHC, Keirao Makting for medical treatment.

 - (2) Md. Huda (21) S/O Md Aton of Keirao Makting Awang Leikai

- and 10/20 of their associates.

I could not report the matter to the concern Police Station in time for medical treatment of the victims as well as to ascertain the miscreants.

It is therefore requested, kindly to take necessary legal action against the above noted miscreants as per law at the earliest.
