



Sir,

I am to bring to your kind notice that I am a residence of Zomi Villa North A.O.C Imphal, Pin-795001. That on 10<sup>th</sup> of April 2024 at around 3:30 pm my above said residence was looted by some unknown miscreants and my house has been illegally occupied by them.

These miscreants have looted every valuable properties from my residence as per inform to me by my source. The looted properties are worth Rs. 9700000/- Rs. 97-lakhs (approx.). The list of stolen properties are listed below:

1. Room (A) - King size bed, mattress, godrej steel Almirah, wooden Almirah, Clothing and utensils.
2. Room (B) - Wooden sofa set (6 piece), Utensils, smart TV (55 inch.).
3. Room (C) - King size bed, mattress, Wooden bed, fridge, makeup table, study table, drawer, dining table, Kitchen Utensils, luxury sofa-set.
4. Room (D) - King size bed, mattress, wooden Almirah, Plastic Almirah, Wooden and Glass Almirah, TV, sewing machine, TV, Clothing and Utensils.
5. Room (E) - Wooden bed, Wooden Almirah, godrej steel almirah, Plastic Almirah, Table and Chair.
6. Room (F) - Wooden bed, Plastic drawer, Bed box, Suit case (5 piece), Utensils and Clothings.
7. Room (G) - Wooden bed, Wooden Almirah, godrej Steel Almirah, Glass Table, Clothing and Utensils.
8. Room (H) - Dining table, Wooden Almirah, Kitchen Utensils, Washing Machine, Fridge (double-door), Bluetooth Speaker and smart T.V. (52 inch.), study table.

The above list of properties are looted from my residence by some miscreants as per report from a reliable source.

I, therefore, request you to kindly take a strong actions against the perpetrators and booked them as per the law of the land.  
I shall be grateful for your kind co-operation and necessary actions.
