The incident resulted in multiple gunshots, causing damage to my property and posing a significant risk to the safety of my family and myself.

This incident has left me feeling vulnerable and fearful for our safety. I am reaching out to your esteemed department to request a thorough investigation into this matter. I urge you to take swift and decisive action to identify the individuals responsible for this reckless and dangerous behavior .Furthermore, I request increased patrols and surveillance in our neighborhood to prevent any further incidents of this nature and to ensure the safety and security of all the residents.I am available to provide any additional information or assistance that may aid in your investigation. Please do not hesitate to contact me at 9402740812if needed.I trust that your department will take this matter seriously and respond promptly to ensure justice is served and the safety of our community is upheld.
