Subject: Request for taking necessary steps regarding threats to me

Sir,

I, the undersigned request you to kindly look into the matter of threats meted out to me and my family members on 12th April, 2024 at around 11:05 p.m. by some unknown masked persons who came in 3 (three) numberless vehicles with sophisticated weapons to my residence at Kyamgei and asked for my whereabouts. Since I wasn't home at that time due to personal works, they threatened my family members and broke some signboards and banners which was put up at my officer. They left after giving a stern warning that I should not get involve in the current electioneering. Since I work for Dr. Angomcha Bimol Akoijam as a constituent of INDIA Bloc, Manipur, they seem to target me. And if I continue with my work, the consequence would be solely upon me.

Therefore, in this connection I would like to request you to kindly look into the matter since this cannot be taken lightly in view of the severity of the situation. I would be highly grateful to you if you will take up some concrete steps that my life would not be in danger.
